At that time, Jesus spoke to His disciples this parable: The kingdom of heaven is likened to a king, who would take an account of his servants. And when he had begun to take the account, one was brought to him that owed him ten thousand talents: and as he had not wherewith to pay it, his lord commanded that he should be sold, and his wife and children, and all that he had, and payment to be made. But that servant falling down, besought him, saying, Have patience with me, and I will pay thee all. And the lord of that servant, being

moved with pity, let him go; and forgave him the debt. But when that servant was gone out, he found one of his fellowservants that owed him a hundred pence: and laying hold of him, he throttled him, saying, Pay what thou owest. And his fellow-servant falling down besought him, saying, Have patience with me, and I will pay thee all. And he would not; but went and cast him into prison till he paid the debt. Now his fellow-servants, seeing what was done, were very much grieved; and they came and told their lord all that was done. Then his lord called him, and saith to him, Thou wicked servant, I forgave thee all the debt, because thou besoughtest me; shouldst not thou then have had compassion also on they fellow-servant, even as I had compassion on thee? And his lord being angry, delivered him to the torturers until he paid all the debt. So also shall My heavenly Father do to you, if you forgive not every one his brother from your hearts.

Then his lord called him, and said to him: Thou wicked servant, I forgave thee all the debt, because thou besoughtest me: Shouldst not thou then have had compassion also on thy fellow servant, even as I had compassion on thee? And his lord being angry delivered him to the torturers until he paid all the debt. (Saint Matthew 18:32-34). It appears from history, and from the civil law of the gentile Romans, to whom at the time of Christ the Jews were subject, that debtors were accustomed to be delivered by their creditors to torturers, who cast them into prison, and scourged them. The Emperor, Constantine, was the first, out of Christian clemency, to abolish the punishment of scourging debtors with flails loaded with lead. Moreover, the torturers are the demons, says Remigius, who torment souls of sinners in hell in a thousand ways. Until he paid, i.e., he must be tormented forever. For he could never pay off that debt of 120 million. So St. John Chrysostom.

And his lord being angry, delivered him to the torturers until he paid all the debt, namely the ten thousand talents which had been already remitted (vv. 24, 27). He goes on to say, So also shall My heavenly Father do to you, if you forgive not everyone his brother from your hearts, that is, He will recall all your past sins which have been already forgiven, even as the lord recalled the past debt of his servant which had been already remitted. This remitted debt, therefore, and sin is said to be recalled and to return, through that subsequent mercilessness and ingratitude.

- 1. Because this want of mercy is a deadly sin; for to be unwilling to forgive our neighbor a fault, is to cherish hatred, anger, and revenge against him, which is clearly a mortal sin. And thus by this means the former state of sin and liability to hell returns. For he who will not forgive is a debtor to the wrath of God in the same way that he was previously, on account of other sins. When someone is damned, it is for some sin that he is damned. Now this sin cannot be remitted, because so long as a man will not forgive his neighbor for a trespass against himself, so long God will not forgive him his own faults. By the fact, therefore, that a similar new sin of mercilessness is committed, by means of it, in some way, past offenses against God seem to live again, because the state of sin and the liability to hell revive.
- 2. Because this ingratitude sorely aggravates the sin, even

mortally, if we believe Soto, who asserts that it must be mentioned by a penitent in confession. Others, though, take a milder view, that the circumstance of ingratitude aggravates the sin to which it is attached, only venially; for this gratitude is not as great as the benefit itself [for which one is ungrateful], or as great as the sin to which it is attached. For this ingratitude attaches itself to all sin; nevertheless its malice and guilt increase proportionately, so that the greater the benefit [received] or the sin remitted to the person, the greater consequently is the ingratitude, but within the limits already mentioned. Ingratitude for the remission that one has received for sins, therefore, in a certain way recalls those past sins, in that it aggravates the following sin.

3. Although this ingratitude is perhaps not a mortal sin per se, yet it is often a cause of mortal sin. For God, on account of this ingratitude, withdraws the more plentiful supply of His grace from the sinner, and permits him to be more severely tempted by the flesh and the devil.

So also shall My heavenly Father do to you, if you forgive not everyone his brother from your hearts. (v. 35) "From your hearts", meaning from the very bottom of your heart. For there are many who forgive with their lips, but not with their hearts. Christ, therefore, bids that the gall of rancor be cast out from the depths of the heart, and the honey of love substituted in its place. This parable, therefore, teaches how gravely displeasing to God it is to harbor in our minds anger, rancor and revenge against a neighbor who has offended us; and, on the other hand, how pleasing it is to God to lay them aside, and convert them into love, even as God receives the penitent sinner to His grace and the bowels of His love, and buries in oblivion all his past offenses, even as though they had never been committed. Moreover, this is to be done not once, but seventy times seven, that is, always, and as often as our neighbor repents of the offense. To demonstrate this, Christ spoke the parable of the ten thousand talents – that is, of a very vast debt. Let us, therefore, who are but men, and very weak men, imitate God, Who every day forgives us our daily offenses against Him, be they very many and very grievous, as often as we repent, and does let us do the same from the heart. And, therefore, He bids us pray daily, Forgive us our debts, as we also forgive our debtors. (The Great Commentary of Cornelius à Lapide)
